SignatureBlue Dental Commissions

Effective Jan. 1, 2024, ASO Block Pricing business will be paid in accordance with the associated administrative services agreement (ASA). Commission payments will be made one month in arrears.

ASO Block Pricing Medical Renewal Bonus

Effective Jan. 1, 2024, a renewal bonus may be earned monthly and will be determined at the group's renewal date. To qualify for the renewal bonus, you must have at least 500 enrolled contracts across all group lines (Small Group (BluePride, BlueFreedom, and Level Funding (ASO)), PremierBlue, Standard Self-Insured (ASO), and ASO Block Pricing), excluding sold contracts that are administered on an alternative platform (e.g., Highmark). This includes business written on a consultant fee arrangement. Any business acquisition that adds to an existing group will be counted in the membership totals. Likewise, any segment of a business sold will be counted against the membership totals.

The renewal bonus calculation rate will be based on your net growth percentage by renewal date. Net growth percentage is calculated by taking the total current members, minus any terminated members, plus any new members on that renewal date, divided by the total number of members in force on the prior calendar year effective date. This will determine your calculated net growth percentage. If the calculated percentage meets the minimum level below and the renewal guideline minimum is met, the payment will be determined by multiplying the current renewal members in force times the renewal rate in the following schedule.

Determination of bonus eligibility and payment amount (if any) will be made at BCBSNE's sole discretion. All determinations made by BCBSNE will be final.
